



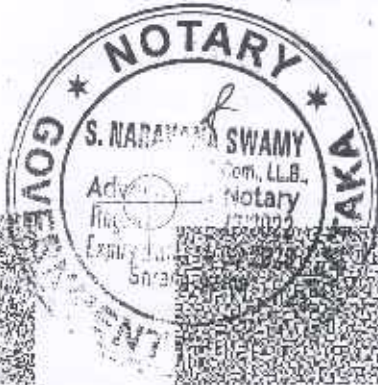

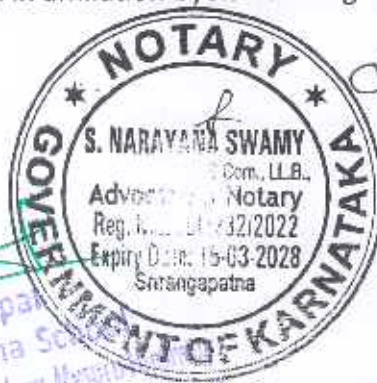
1. That the OOM SHREENIKETHANA TRUST (R) (under section 8) is a registered Society/Trust under the Indian Trust Act 1882.
