Shall provide separate toilet for Boys & Girls. Shall locate in healthy and sanitary surroundings. To ensure that all dangerous places and areas within the premises of the educational institution are fenced around for the safety of students and to take necessary steps to avoid fire accidents under the Rules 4, 5, 6 and 8 on Security measures.

3. The Educational Institution shall not open additional sections without prior permission from the Government.
4. As per Karnataka Education Act Section 41b, the school shall open on the same medium of instruction and same place and course with provision to suit the school.
5. After obtaining the permits on day and management, shall run the Institution by the same management and on this same place and should not transfer to another management without prior permission from the Government.
6. This educational Institution shall follow all the rules and regulations time to time implemented by the Government. Shall follow the rules and regulations incorporated under Karnataka Education Act 1983 (Karnataka Act No. 1/95) without fail.
7. As per Government Notification No. ED/175/VAC/84, dated 7-9-1988 and dated 23-12-1985, this institution shall be run on the basis of permanently without-aid.
8. Shall follow / obey the rules coming under Karnataka Private Educational Institutions (Discipline & Regulation) Rules, 1999.
9. As per the Karnataka Educational Institutions (Classification, Regulation and Prescription of Curricula etc.) Rules, 1995, shall teach only the books as prescribed by the education department and government and so take care the books shall not be given to students.
10. As per the Karnataka Educational Institutions (Classification, Regulation and Prescription of Curricula etc.) Rules, 1995, shall collect only the Term Fee, Tuition Fee & Special Development Fee as per Rules, 10, dated 4-10-1996 and shall print the details of fee to be collected from the Students/Parents in the Brochures and display in the School Notice board. Copies of the same to be submit to the Block Education Officer/Deputy Director of Public Instruction.
11. Shall follow the rules compulsorily as per the Government Notification No. ED/39/Vivid/99, dated 24-3-2000, Karnataka Educational Institutions (Regulations of certain fees and donations) and shall not collect any type of donations as per the rules.
12. After obtaining permission, shall submit the application within 7 months as per the Karnataka Education Act 1983 (Act 1 of 1995) as per Sec. 36 to 39, ED/137/Vivida/97, Bengaluru, dated 4-11-1997 to obtain the Renewal of Recognition as per the Government Notification No. ED/37/Vivid/98, Bengaluru, dated 19-5-1998, to the concerned authority. To open the school, the management shall keep the stability fund in the joint name of the Deputy Director of Public Instruction and the Secretary of the Management.
13. Shall follow the medium of instructions and to teach in Kannada Medium or Children's Mother Tongue for the classes from 1 to 5th Standard as per the Government Order No. ED/28/RGC/94, dated 29-4-1994.
14. Shall follow the Students & Teachers Ratio in each class the permission as per the Government Notification No. ED/52/Vivid/99, dated 2-2-2000 (Annexure).
15. Shall recruit only the qualified trained teachers as per the rules and regulations of Education Department.

19. Compulsorily open the service book of all the teachers/staff those who are appointed. She record all the service details in the book and follow the rules as per the Government Circular No: ED/27/SFP/2003, dated 13-2-2003.
20. Shall depute the teachers for census work without fail.
21. Shall not exceed 50 students in each class.
22. There shall be no provision for shifting or transferring the school within 5 years of permission granted.
23. Shall comply the conditions of the government letter No: ED 122 SFS 2007, Bangalore dated 14/01/2007.
24. Should follow the medical instructions issued to school for which permission is granted.
25. As per government notification no. ED 309 PCC 2014, dated 11/11/2014 and allied modification order, school shall fulfill all fundamental facilities and other conditions compulsorily. And in this regard the first permission can be granted only after confirming by the Block Education Officer.
26. In the purview of safety of the students, all necessary safety measures shall be implemented as per the directions of Education Department and Home Ministry Department.
27. Concerned Block Education Officer shall have proper vigilance regarding school registration condition being followed.
28. If found any fake documents have been produced or found not correct and found not to follow any conditions, the department shall hold the school right to cancel the registration.

12. Should follow the Student-Teachers Ratio in each class as per the recognition granted by the Government Notification No. ED/52/V/99, dated 2-2-2000 (Rule 5, Annexure).
13. School should recruit only the B.Ed. & trained teachers as per the rules and regulations of Education Department.
14. Shall procure all fundamental prerequisites like sufficient furniture, teaching aid, library & etc. within one year and shall have its own playground and school building within three years as per the Karnataka Education Act, Rules.
15. Should follow the school working hours and Dates as per the Education Department Rules.

28. Shall fix Fire Extinguish equipments.
